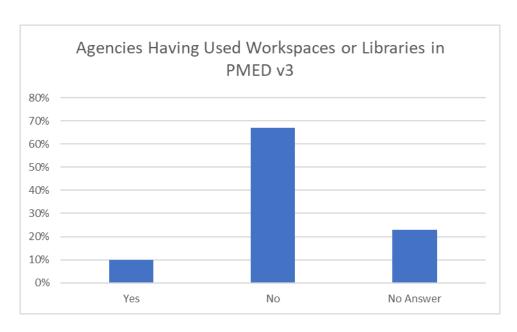

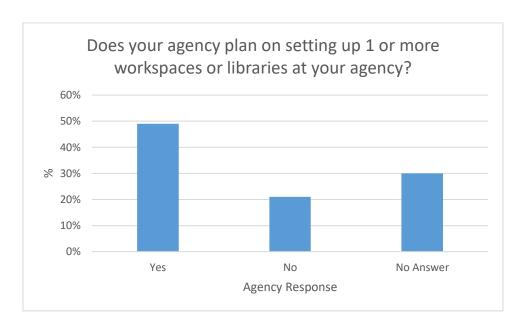

### 6 Webinar Questions and Answers

The following provides an answer or response to all questions asked during the webinar.

### Q: Integration of climate data is - awesome!!

A: We are happy to hear that!

### Q: Does ME v3.0 allow users to change Calibration Factors manually?

A: Yes. The design/project specific calibration factors can be adjusted as in the desktop application

## Q: Can we enter the calibration factor from central office so the individual users do not need to enter that for individual projects anymore?

A: Yes, that is possible. You can set up the specific workspace to use only those calibration coefficients. You can also set up different workspaces for different regions, offices, etc.

### Q: If a tenant forgets to log out can the admin log them out without removing them?

A: Yes. Going into the user menu and clicking the "Active" button to set them to inactive should log them out/vacate their subscription seat.

### Q: Can we have more than one group admin? In case Admin is away.

A: Yes.

### Q: What is the limit of max. number of users? How many users can work co-currently? Is that the seat associated with the account?

A: This is the dependent on the number of seats in your subscription. You can have a number of concurrent users equal to those seats. I don't believe there is a limit on the number of registered users, but there is a limit on the concurrent users

#### Q: I do not see an active button in user menu.

A: I was mistaken, it's the "Access" column in the user menu. Clicking the "Yes" should flip it to "No" and that will vacate the seat.

#### Q: Is there any user manual on this web-based V 3.0 that you can share?

A: Yes, the help manual is available online through the web app.

### Q: Does current Calibration Assistance Tool (CAT) be used to perform local calibration for ME v3.0?

A: Yes.

### Q: Is there any limit on the number of admins?

A: There is no upper limit, but there is a minimum requirement of one admin.

### Q: Is it possible to grant a User access that is outside of an Agency?

A: Yes. Users can be invited via their email and there is no requirement that they reside inside any specific agency.

Q: Okay I can follow up with you. I did disable the access yesterday and it didn't vacate the seat.

A: We will follow up.

### Q: Does any server connectivity issue adversely affect performing the design?

A: No. It is possible that if the server is under a heavy load that the design being run may need to sit in the queue. However, we have implemented a "fair queue" service that interweaves analysis requests based on when they were requested. This means the maximum time you might wait in a queue is equivalent to a single run of a design.

# Q: Since there maybe a limited number of seats. Is it possible to rank the seat users so that a user maybe bumped?

A: This is not currently possible. However, since the webinar this has been added to the backlog of feature improvements.

### Q: Is there any limit on the number of tenants or Is it based on the number of license subscription?

A: There is not a limit on the number of *users* that belong to a tenant. Your agency can invite whoever they like. However, you can only have a number of concurrent users on at a time equal to the number of concurrent license seats you purchase.
